**Eliot Spitzer**, Attorney General for the State of New York, has reached a settlement with **CBS Radio** regarding the Payola investigations taking place in his office. CBS has agreed to undertake reforms and immediately end airplay. CBS will also dole out \$2 million through the Rockefeller Philanthropy Advisors to New York State non-profit entities that fund music education and appreciation programs. \$50,000 will also be given to OAG's office to cover investigation costs. This settlement follows four other settlements with **Sony BMG**, **Warner Music Group**, **Universal Music Group**, and **EMI**. Spitzer is negotiating with six other broadcast companies about similar settlement.

**Entercom Communication's** request for dismissal in the Payola suit brought by NY State Attorney General **Eliot Spitzer** has been denied. The case will now move forward in the courts, in a ruling by New York State Supreme Court Judge **Ira Gammerman**. Says a spokesman for Entercom: "While we are disappointed by the court's decision to permit this case to proceed beyond this early stage we continue to believe that the evidence will show that the Attorney General's case is without merit. This ruling was not an assessment of the merits of the case, but rather of whether the allegations were sufficient to avoid dismissal at the outset of the case. Entercom continues to comply with federal sponsor identification rules, and we continue to enforce our policies prohibiting Payola." There has been no official comment from Spitzer's office.

**Hubbard** news-talk **KSTP-AM/Minneapolis** came under fire earlier this week in a Minneapolis *Star-Tribune* article which asked the question: "Do listeners care if their Twin Cities radio host is 630 miles away? KSTP-AM is putting that concept to the test." At the center of the question is the station's new midday personality, **Sterling (Schliesser)**, who broadcasts from his home in Columbus, OH. Trib reporter **Deborah Caulfield Rybak** takes issue with his locality, stating "Although he mentioned Ohio ...he never told listeners that he was broadcasting his noon-to-2 p.m. show from its capital city, and has done so every day since early September, when he started full time at KSTP." She enlisted **Michael Harrison**, editor of *Talkers*, to opine: "It's a bad thing to make people think that the person is actually in a city when they are not. It's extremely dangerous and problematic." And **Bob Steele**, a senior ethics faculty member at the Florida-based **Poynter Institute** journalism think tank, called the practice "ethically disingenuous." KSTP general manager **Todd Fisher** brushed aside the question, saying, "It's a

widespread practice. There are plenty of people who are phoning it in from their winter homes in Florida. You'd be surprised at who does that here." (The Trib could not find any operators in town to support his 'phone it in' assertion.) While Sterling's presence on the air is admittedly different than using voice-tracking and syndicated talent to fill out air shifts, Fisher got to the point: "There's a lack of talent in the industry." (Shameless plug: For any talent in or near Charlotte, NC this weekend, the **Conclave's TalenTrak** will seek to help remedy that situation!). The article closed with Harrison stating, "It's a controversial issue that needs to be addressed, because this practice is only going to increase. If you're creating an atmosphere of localness that you're not really sharing, in terms of credibility, you're walking a dangerous line."

Two group calling themselves the **Right to Decency, Inc.**, and the **American Decency Association**, have challenged the Consent Decrees that would allow **Viacom** to settle formerly outstanding indecency claims. The **FCC** has rejected this challenge. Viacom had voluntarily paid \$3.5 million to the Commission, anti-**Mancow** pundit **David Smith**, the **Illinois Family Institute**, the **Concerned Women for America** (Illinois Chapter), and **Julie Cordry**, which challenged **Emmis's** similar Consent Decree for \$300,000. The FCC claims that in each case it had the power to make the deals and considered all previous violations in doing so.

The **Omaha City Council** has decreed that **Clear Channel** Talk **KFAB-AM/Omaha** must issue a public apology for spoofing North Omaha's tourism effort on **Tom Becka's** show. The lampoon featured spoofs on the area's gang violence and the Community's "stop snitching," attitude, but council members from North Omaha were offended by the satire. No community members showed to support the resolution, but Becka had several supporters. The station did post an apology online, but now airs a parody mocking the city council.

**Mike Veeck**, son of baseball's popular showman/author **Bill Veeck**, and former owner of the St. Paul Saints and the Sioux falls Canaries, is pioneering "Potluck Cafe," a brand-new food show airing on **Citadel** Talk **WTMA-AM/Charleston, SC**. The show is being co-hosted by **John Schumacher**. Veeck owns the Charleston River Dogs, where Schumacher heads up food and concessions for the team, as well as the four other teams owned by Veeck, **Marvin Goldklang**, and co-owner of the Saints, comedian/actor **Bill Murray**. Veeck has keynoted **The Conclave** twice!

**TUITION, just \$59 at the door**

Election politics in Minnesota got a bit more controversial, with a former Twin Cities air personality in the thick of blackmail accusations. Last year, State Rep. **Keith Ellison** – now the Democratic candidate for Minnesota's 5<sup>th</sup> congressional district seat - obtained a restraining order to keep a former constituent away from him and his family. Now, his campaign is accusing the woman (**Amy Alexander**) of working with a friend to blackmail his congressional campaign at the same time she is seeking a restraining order *against him*. That friend is Minneapolis free lance reporter and former KSTP/WLTE personality **Mesa Kincaid**. In a Minneapolis *Star-Tribune* article yesterday, Ellison's campaign manager said in the motion that Kincaid "recounted vague allegations by Alexander against Rep. Ellison personally as well as allegations that he was having romantic affairs with numerous people." The Ellison motion also said that "in several phone calls, Kincaid demanded that the campaign pay her and Alexander \$10,000, in return for which payment Alexander would not 'tell her story.'" Kincaid told the newspaper, the allegations are "completely false", adding - "I never spoke of money or anything to (the campaign manager). There are no legs to this." Alexander's request for a restraining order will be heard later in November, after the elections. Now, back to tonight's episode of "Desperate Housewives"...
